The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, 3 (three) estates on 6 to 11 September 2021.

Bumitama Agri Ltd founded in 1996 and listed on the Singapore Exchange in 2012, is one of the leading producers of crude palm oil (CPO) and palm kernel (PK) in Indonesia. The Group harvesting is principally engaged in the cultivation of oil palm trees, as well as the harvesting and processing of fresh palm fruit bunches (FFB) into CPO and PK, which are then sold to refineries in Indonesia. As of 31 December 2020, total planted area is 187,917 hectares and operate 14 CPO mills with a combined processing capacity of 6.03 million tonnes of fresh fruit bunches annually.

PT Karya Bakti Agro Sejahtera started planting oil palm in 2010 and the NPP process was completed on 04 November 2016 (https://rspo.org/certification/new-planting-procedure/public-consultations/bumitama-agri-ltd-pt-karya-bakti-agro-sejahtera-3).

The LUCA process has been reviewed and approved by the RSPO. PT KBAS is also covered by the Bumitama Compensation plan which is currently in the RSPO review process.
